No. PB10EF-4986 driven by Karamjit Singh(31) s/o Surender Singh of Jalandar, Punjab, while proceeding towards Imphal met a self accident near Leikop Village on NH-2 due to rash and negligent driving on the part of the above driver. As a result, the above driver sustained injury on his person and evacuated to hospital for medical treatment and the above Tata Truck also got badly damaged and blocked the public traffic system.
