Sir,

I have the honour to report that, I am resided at Kangpokpi Shanti Veng Ward No. 17 since last 50 years back. However on 03/05/2023 at around 5:30 pm, I along with my whole family had fled away from my residence due to fear & safety of life in c/w present ethnic violence in the State and taking shelter at Kanglatongbi Tispari, Imphal West District, Manipur.

That, on 26th October, 2023 it comes to light that, my houses along with many valuable properties were vandalized by unknown persons suspected to be Kuki Militants & rioters. They also looted many valuable properties i.e furniture items, kitchen items, utensil items, electronics items, cash (Rs 52,000/-) etc. The approximate value of the properties that were vandalized & looted is estimated about Rs 2 Lakh.

Regarding the matters I couldn't able to report to the concern PS i.e. Kangpokpi PS till date due to the present situation in the State. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
