Sir,

Today i.e. 01/09/2023 at 2:00 pm received an input regarding transportation of arms & ammunitions in the general area of Chandraman village about 7 kms south west of KPI-PS. Joint teams comprising Kangpokpi police led by OC/KPI-PS along with F/119 Bn. CRPF and 22-AR COB-KPI under the supervision of SP/KPI have conducted a search operation cum adopting area domination and sensitization of the jurisdiction of Kangpokpi Police Station from 3:00 pm till 5:30 pm. While conducting the search operation in the suspected area of southern side of Chandraman village on the same day at around 5:30 pm, seen the movement of three individuals along with arms bumbling around the paddy field in a suspicious manner in a far-off location. On seeing the search operation teams, the three individuals suddenly ran towards the bushy area where they managed to escape it from the arrest of the search operation teams. The joint teams then immediately cordoned the area by firing some ammunition in the air; however, they managed to escape taking advantage of nearby jungle. Then a search was conducted inside one hut in the paddy field in the said location where one 7.62 mm(1-A, SLR Rifle) B/R No. 15371372 without magazine along with 4(four) live rounds of 7.62 mm ammunitions and one local made Canon (Pumpi) which were wrapped in a sack. A necessary formality has been observed in connection with the seizure.

The seized items are being handed over to you for further necessary action.
