

Sir,

I have the honour to report that today, the 10th January, 2023 from 8:00 A.M. to 2:30 P.M. a joint team of Kangpokpi District Police led by DSP/GSPM, SDO/SDM Champhai Sub-Division, Kangpokpi Range Forest Office, NAB – Imphal, NCB- Imphal, 22 AR KPI Post and police officers with personnel of KPI-PS, G-SPM-PS, RL/DHQ under the supervision of SP-Kangpokpi and DFO/Kangpokpi conducted destruction of illicit Poppy plants at Thotne village Koubru Hill Range under the jurisdiction of Kangpokpi Police Station in which illegal Poppy plantation of about 25 acres which were planted by breaking of land prohibited in the reserved forest land were completely destroyed.

It is therefore, requested kindly to take up further necessary legal action as per provision of law.
