Sir,

Today i.e. On 4/01/2023 at around 11:40 am, a joint team of Kangpokpi District Police, NAB, Forest Department, Kangpokpi SDO Saikul Block, Kangpokpi District numbering about 41 (Forty-one) persons led by Shri. L. Sheimang Khongsae, MPS, DSP/GSPM/KPI under the supervision of Smt. Amrita Sinha, IPS, SP-KPI carried out a mass destruction of illicit poppy plants cultivation at the hill range of Pangjang Village under Saikul Sub-Division, Kangpokpi District, Manipur about 7km North from the Saikul Police Station in which illegal Poppy plantation of land covering about 15 (fifteen) acres were destroyed.

It is therefore, request to take up necessary legal action.
