It is pertinent to mention here that the contents of the above mentioned fake document/press release is clearly promoting enmity between communities on the ground of language. Nevertheless, such forged publication is dangerous keeping the ongoing disturbance in the State of Manipur and is defamatory in nature. Therefore, I request your good office to do the required investigation in the interest of justice.
