Subject: Report of criminal intimidation and un-lawful displacement.

Sir,

With due respect I have the honour to state that on 3rd and 4th May 2023 at Kangpokpi Bazar at our rented house some unknown miscreants well-armed suspected to be youth belonging to Kuki community numbering about 500-1000 came at our rented house and started destroying and looted our belongings. These criminals broke the door, destroyed, looted, and vandalized every valuable property from premises which is worth Rupees 10 Lakhs (Aprox). That on 5th May 2023 I along with my daughter, my sons and my grandson were rescued by Central force team and brought to Sekmai PS for our safety. Later we came at my elder sister's residence located at Achanbigai Mayai Leikai and have been staying there till date.

Therefore, with utmost respect I request you to take strong action against the perpetrators by registering an FIR under relevant sections.
