Sub: Report.

Sir,

I have the honour to state that today i.e on 17/04/2023 at about 11:00 am a teams of KPI-PS led by SI S. Raju Singh while conducting intensive regular frisking and checking of vehicles at Check Post of Kangpokpi Police Station's Gate along NH-2 under the overall instruction of Shri Th. Vikramjit Singh, MPS, SP/KPI and under the direct supervision of OC/KPI, one registered Winger bearing number MN06LA- 3936 coming towards Kangpokpi driven by Ali Nongshaibam @ Sultan (33) S/o (L) Idrish Ali of Yairipok Sepoy Leikai was stopped for checking. While checking one after another, two occupants inside the Winger were found behaving in a very suspicious manner. The two occupants were tactfully examined separately at the spot and during which the lady occupant admitted the presence of contraband drug inside her backpack (black colour) in which she transported the same together with the other male occupant. The female occupant was identified as Asheibam Thoibi Devi, aged about 38 years W/o Nongthombam Premananda Singh of Huikap Mayai Leikai, Imphal-East, Manipur and the male occupant as Md. Abdul Matalip, aged about 40 years S/o MV Kashim of Thoubal Moijing Wangma Taba, Mayai Leikai, PO/PS-Thoubal, Thoubal District, Manipur.

On confirming the presence of drugs inside the bag, no further checking was done in order to observe formalities at the spot and the two aforesaid occupants were detained. So, immediately Senior Officer of the district namely Shri Tholu Rocky, MPS Addl. SP (L&O), Kangpokpi and 1 (one) Executive Magistrate namely Sithonliu Pamai, SDC/BO, Kangpokpi were informed the matter and requested to be present at the spot. On arrival of Executive Magistrate SDC/BO Kangpokpi at the spot, the detained female Asheibam Thoibi Devi took out one transparent polythene bag containing suspected to be Brown Sugar which was concealed inside the bottom of the backpack. In presence of executive magistrate and witnesses, weighing of the recovered suspected drug was performed and found 1.018 Kgs including the weight of the polythene bag and marked it as Lot-1 for identification.

The recovered one transparent polythene bag containing suspected Brown Sugar weighing 1.018 Kgs and other articles were seized in the presence of executive magistrate, witnesses and detained persons by preparing a formal seizure memo and also obtained their signatures at 12: 10 pm. The two detained persons were arrested at 12: 20 pm in the presence of witnesses by preparing a formal arrest-memo.

## Particulars of seized articles

1. One transparent polythene bag containing suspected to be brown sugar weighing 1.018 Kgs including the weight of the transparent polythene bag.

2. Two Aadhar cards bearing numbers 5239, 2511, 4107 & 4492, 9923, 1250.

3. One Mobile Nokia Handset containing Sim No. 9233826926 from the possession of (Md. A Abdul Matalip) of Thoubal Moijing Wangma Taba Mayai Leikai Thoubal Dist.

4. Redmi C-12 bearing Jio No.7005822217

- 5. Redmi 6A bearing Jio Sim card no. 6009665021
- 6. Nokia handset bearing Airtel Simcard no. 8974537636

Following the order passed by the Hon'ble Spl. Judge, ND&PS, Manipur vide No. SPL-C/ND&PS/2019/659-663 dated 26-11-2019 corresponding Cril. Appeal No. 652 of 2012 (MANU/SC/0073/2016: (2016) 3 SC & 379) the necessary proceedings laid under ND&PS Act will be observed before the Hon'ble Court of JMFC, Kangpokpi.

Therefore, the arrested two accused persons and seized items are handed over to you for taking further necessary legal action please.
