Sir,

Today i.e. 29/09/2023 at 12:20 pm received specific inputs from source regarding concealing of arms & ammunitions in the general area of South Changoubung jungle about 3 ½ kms North West from KPI-PS by unknown miscreants. Accordingly a joint teams comprising Kangpokpi police led by OC/KPI-PS along with F/119 Bn. CRPF, D/68 Bn. CRPF and 22-AR COB-KPI under the supervision of SP/KPI and ASP (L&O), Kangpokpi. Exact location of the area was received and located from source where arms and ammunitions were concealed. After a brief search of that particular area, the following arms and ammunitions were recovered from the bushes not too far away from the Kuccha Road at 2:20.Pm. The recovered items were brought to KPI-PS for further necessary formalities. The recoveries are:-

1. 1 No. of 303 Rifle with sling (B/Regn. No. A10790).
2. 1 No. of 303 Magazine.
3. 3 Nos. of 303 live rounds ammunitions.
4. 1 No. of Local made mortal (Pumpi).

It is therefore requested to take up necessary legal action as per law of the land.
