Sub: - Request for lodging of FIR case regarding looting and
ransacking/burnt down of my house and shop located at
Chaljang Village, Kanpokpi District.

Sir,

I, the undersigned have the honour to state that large number of innumerable unidentified group of people belonging to Kuki Community with deadly weapons and sophisticated arms including kuki militants groups stormed to all Meitei inhabited areas of Chaljang Village on 4th May 2023 at around 1.30 pm. The said unidentified groups vandalized/burnt down my house and shop and looted all valuable items. In that unfortunate incident, I have lost a total amount of Rs. 22,00,000/- (Twenty two lakhs). After the said unfortunate incident/ mob violent, my family are fleeing our village and my family is taking shelter at a relief camp situated at Wangkhei High School, Imphal East District, Manipur.

It is therefore, prayed that the respected sir may kindly initiate and take necessary legal action(s) against the persons and the persons involved in the said inhuman acts and heinous crime committed by the accused persons and persons involved as per law of the land as early as possible.
