I, the undersigned, have the honour to state that large number of unidentified groups of people belonging to Kuki community with deadly weapons and sophisticated arms including Kuki militant groups stormed to all Meitei inhabited areas of Kanapahar, Tumnoupokpi, Kangpokpi District on 4th day of May (Thursday), 2023 at around 3.00 pm. The said unidentified groups burnt down my house including valuable items as mentioned below:

- 1. House (wooden newly built store /dukan)
- 2. Furniture (2 almirah, 2 Beds, sofa, others etc.)
- 3. Vehicles (1 bicycle)
- 4. Kitchen items (3 gas cylinders, Rice cookers, utensils, etc.)
- 5. Electronics items (TV, Refrigerator, heater, fan etc.)
- 6. 20-ducks and 20 hens (30 Flocks)
- 7. Wood and steel roofing sheet other clothing items, Rice Grain (30 Bags),

In that unfortunate incident, more than an approximate amount of Rs.25,00,000.00/-(Twenty five lakhs) worth property has been lost. After the said unfortunate mob violent, my family members fled our village and presently taking shelter at Hiyanglam Girl High School, Relief Camp.

It is, therefore, prayed that respected Sir may kindly initiate and take necessary legal actions against the accused persons and persons involved in the said inhuman acts and heinous crimes committed by the accused persons and persons involved as per law of the land as early as possible.
