Sir,

I have the honor to report that today i.e. 01/02/2024 @ 09:00 am, while conducting random checking and checking near Martyr's Park, Mao about 2Kms south from the P.S. one Maruti Swift VXI (white in colour) bearing Regd. No. ASD1BJ-0574 was seen coming from Sonapati side towards Nagaland. The said vehicle was stopped for checking and checking. On enquiry, the driver of the vehicle is identified as Md. Zahid Khan (34 yrs) S/o (L) Md. Nasimuddin of Haoshibi Nagai Leikai, Lilong Thoubal District, Manipur, he stated that he is coming from Lilong Thoubal District Manipur and heading to Dimapur for some work. On checking the vehicle, suspected brown sugar was found concealed on the dashboard of the car. As such DC/PT has been intimated and a request was made to depose one Magistrate. Accordingly ADM/Mao Shri. Ningreingam Leikan (45) yrs (Executive Magistrate) was deputed for doing the necessary procedures.

On arrival of the Executive Magistrate and in his presence and in the presence of the driver namely Md. Zahid Khan (34 yrs) S/o (L) Md. Nasimuddin of Haoshibi Nagai Leikai, Lilong Thoubal District, Manipur, the vehicle was thoroughly checked. On checking 10 (ten) soap cases were found concealed on the dashboard of the car.

The 10 (ten) Soap cases were weighed by using weighing machine in presence of the Executive Magistrate and witnesses and it was found to be 111.80 grams including the weight of plastic packet (without the weight of the soap cases). The approximate value is Rs. 1,11,800 (One lakh eleven thousand eight hundred only). The 10 (ten) soap cases of suspected brown sugar was seized in the presence of Executive Magistrate and witnesses by preparing a formal seizure memo. The detained person was formally arrested at 10:00 am by observing formalities.

#### Particulars of the seized items:

- 1.) 10 (ten) soap cases suspected to contain brown sugar, weighing 111.80 grams including the weight of plastic packet (without the weight of soap cases).

Site. I have the honour to report that today i.e. 04/02/2024 @ 03:30 pm, while conducting random frisking and checking near martyr's park Mao about 2 kms. South from the PS, one winger (omni bus) bearing Regd. No. MN 9C-0012 was seen coming from Senapati side towards Nagaland. The said vehicle was stopped for frisking and checking. On enquiry, the driver of the vehicle is identified as Md. Kabirjuddin (34) yrs. s/o Md. Anamuddin of Yaikipok Tulihal Kengil Leikai, Imphal East Dist., Manipur. On checking the vehicle a black bag marked as Kaybar was found between the two passengers namely 1) Md. Azad Khan (24) yrs. s/o Md. Oli of Lilong whoipokpi Thoubal Dist., Manipur and (2) Khullakpam Yumush Khan (25) yrs. s/o (2) Kh. Razao of Yaikipok Tulihal Awang Leikai, Imphal East District, Manipur. On enquiry the 2nd passenger namely Khullakpam Yumush Khan (25) yrs. s/o (2) Kh. Razao of Yaikipok Tulihal Awang Leikai, Imphal East District, Manipur stated that the bag belongs to him and his co-passenger namely Md. Azad Khan (24) yrs. s/o Md. Oli of Lilong whoipokpi Thoubal District, Manipur. On checking the black bag, suspected brown sugar was found inside the bag. As such DC/SPT has been intimated and a request was made to depute one Magistrate. Accordingly Asst. Mag. Shri. Ningkeingam Leihan (45) yrs. (Executive Magistrate was deputed for doing necessary procedures.

On arrival of the Executive Magistrate and in his presence and in the presence of the driver namely Md. Kabirjuddin (34) yrs. s/o Md. Anamuddin of Yaikipok Tulihal Kengil Leikai, Imphal East District, Manipur and the two passengers namely 1) Md. Azad Khan (24) yrs. s/o Md. Oli of Lilong whoipokpi Thoubal District, Manipur and (2) Khullakpam Yumush Khan (25) yrs. s/o (2) Kh. Razao of Yaikipok Tulihal Awang Leikai, Imphal East Dist. Manipur the bag was thoroughly checked. On checking 14 (fourteen) soap cases were found inside the bag suspected to contain brown sugar.

The 14 (fourteen) soap cases were weighed by using weighing machine in presence of the executive Magistrate and witnesses and it was found to be 172.08 grams including the weight of plastic packet (without the weight of the soap cases). The approximate value is Rs. 1,72,080/- (one lakh seventy two thousand eighty only). The 14 (fourteen) soap cases of suspected brown sugar was seized in the presence of Executive Magistrate and witnesses by preparing a formal seizure memo. The detained persons were formally arrested at 04.00 pm by observing formalities. particulars of the seized items:

1. 14 (fourteen) soap cases suspected to contain brown sugar, weighing 172.08 grams including the weight of plastic packet (without the weight of soap cases).
2. One black bag marked as Graybag.

5. One mobile phone model name GTRNE with IMEI-1 862286022557346 and IMEI-2 862286022557346 along with one Airtel SIM bearing NO. 9233103929.
6. One Aadhaar card namely Md. Azad Khan (24) yrs. s/o Md. Oli of Lilong whoipokpi Thoubal Div. Manipur bearing NO. 443958241347.

Therefore the arrested individuals and the seized items were handed over to you for taking further necessary legal action please.
