Today, the 16th February, 2022 at 7:05 pm received a reliable information that on the same evening at about 6:55 PM some unknown persons stated to be the party workers of BJP KPI A/C and JD(U) KPI(A/C) involved in physical fight in the vicinity of JD(U) KPI A/C Candidate's temporary office situated at Upper Kalapahar. It is stated that few rounds of blank fire had been fired. Immediately a team of Police led by ASI Thangkhopau Gangte of KPI-PS rushed to the spot immediately. By the time the police team reached the spot, shouting and tussle still continued. The Police team separated the two parties and one party fled from the spot in 3 Vehicles immediately. On query by the Police Team, it came to light that two persons of JD(U) supporters sustained body injuries and evacuated to hospital by team of Kangpokpi Police led SI Seigoulen Sitlhou.

Hence, a Suo-Motu case under FIR NO. 12(2)2022 KPI-PS U/S 307/326/171 (C)/160/34 IPC & 25(1-C) A.Act has been registered for investigation.
