Today i.e. On 16/02/2023 at around 11:50 a.m., a joint team of Kangpokpi District Police, NAB, MR/IRB and Forest Department, Kangpokpi SDO Lhungtin block, Kangpokpi District, numbering about 98 (Ninety eight) persons led by Insp. B. Lunthang Vaiphei OC/Saikul-PS under the supervision of Shri. Th. Vikramjit Singh MPS, SP/KPI carried out a mass destruction of illicit Poppy plants cultivation in the hill ranges of Old Bolgang village, under Lhungtin Sub-Division, Kangpokpi District, Manipur about 25 kms North from Saikul police station in which illegal poppy plantation of land covering about 10 (ten) acres were totally destroyed.

Hence, a regular case on sub-motto under FIR No. 12(02)2023 S.K.P. u/s 18(b) NDPS Act. has been registered for investigation.
