Today i.e. On 18/02/2023 at around 11:50 a.m., a joint team of Kangpokpi District Police, NAB, MR/IRB and Forest Department, Kangpokpi SDO Lhungtawakbaikha, Ikingpokpi (District), numbering about 98 (Ninety eight) persons lead by Insp. B. Lunthang Vaiphei OC/Saikul-PS under the supervision of Shri. Th. Vicksamay Singh MPS, SP/KPI carried out a mass destruction of illicit Poppy plants cultivation in the hill ranges of Old Bolang village, under Lhungtin Sub-Division, Kangpokpi District, Manipur about 25 Kms North from Saikul police station in which illegal Poppy plantation of land covering about 10 (ten) acre were totally destroyed.
