Dear Sir,

I am to inform you that our Truck bearing registration No. AS01MC-2765 was loaded with 914 (Nine hundred and fourteen) packages of H.L. Medicine and some other miscellaneous good items weight 8952 Kgs. to be distributed to various location in Imphal which is reflected in manifest No. GHT-589 Dated: 30/11/2023. The above truck was on its way to Imphal near Koubru Laikha Mandir, the driver was compelled to stop the truck due to some mechanical snag. As the driver was looking into the Snag, some persons numbering 5/6 came nearby the truck and looted near about 50-60 cases of H.L medicine on gun point at near Koubru Laikha Mandir on 06/12/2023 at around 11:30. Pm. The matter could not be reported on time as I was engaged in family program at Guwahati, Ulubari, Assam.

I am requesting you to please register a case to arrest the culprits/miscreants as well as recover the looted goods and take up necessary legal action as per law.
