Subject:- Request for lodging of FIR case regarding looting and ransacking/burnt down of my house located at Kalaphar Tumnoupokpi on 3rd May 2023.

Sir,

I, the undersigned have the honour to state that large number of innumerable unidentified groups of people belonging to Kuki community with deadly weapons and sophisticated arms including kuki militants groups stormed to all Meitei inhabited areas of Kalaphar Tumnoupokpi on 3rd day of May 2023 at around 12:00 pm. The said unidentified groups vandalised/burnt down my house and looted all valuable items. In that unfortunate incident, I have lost a total amount of Rs. 2,00,000/- (Two lakh). Their illegal act lead many properties turned into ashes and disturbing peace and tranquilities to the general public heavily.

It is, therefore, prayed that the respected sir may kindly initiate and take necessary legal action(s) against the accused persons and the persons involved in the said inhuman acts and heinous crime committed by the accused persons and persons involved as per law of the land as early as possible

I shall be grateful for your kind co-operation and necessary actions (s).
