I have the honour to report that on the 27<sup>th</sup> March, 2023 my daughter namely Muna Basnet (19) yrs. w/o Robin Katwal of Thaldara village, Irang Part-II, Kangpokpi District on the same day at around 6:00. am along with her husband they went together from their village, Thaldara and reached Kangpokpi Bazar at around 9:00 am. From Kangpokpi they were going in different directions, his husband Robin Katwal went to Senapati side for driving vehicle and my daughter Muna Basnet went towards Kanglatongbi side. But till now she did not return home and also she did not pick up a telephonic call. She is suspected to be kidnapping by unknown persons.

I, therefore, humbly request you to look into the matter and take up necessary legal action.
