Today i.e. 24/12/2023 at 3:30 am ASI Lienjakai Haokip of KPI-PS who was NDO report that on the same day at about 3:00 am, he came across a viral video through social media regarding burning down of medical equipments by some unknown miscreants at undisclosed location (probably within the jurisdiction of KPI PS). On enquiring about the matter as per source report, it was ascertain that one Tata mobile (bolero pick-up) B/Regn. No AS01PC 6863 ferrying medical equipments was stopped somewhere at Kangpokpi Bazar by unruly mobs numbering about 300-400 in the afternoon of 23/12/2023 and kept concealed somewhere at Kangpokpi. Later at around 10 pm, the vehicle along with the medical equipments was taken towards Government High School, Kangpokpi and the medical equipments were burnt down into ashes near Government High School, Kangpokpi while the driver and the vehicle were released safely.

Hence, a Suo-Muto case is registered under FIR No. 129(12)2023 KPI-PS U/S 147/148/149/435/34 IPC for investigation.
