On 23/12/2023 at 10:00 pm received reliable information that on the same day at about 4:30 pm an incident of hit and run took place at Kalapahar near Car Wash centre along NH-2 where one Bolero (white color) B/R. No. unknown driven by unknown person moving towards Senapati knock down one Motor Bike (X-Pulse) B/Regn. No. MN-06SH-1868 coming from the opposite direction ridden by Lalminthang Kipgen (34) S/o (L) Ngamneo Kipgen and the pillion rider namely Seikhogin Kipgen (36) Yrs. s/o (L) Seilal Kipgen of L. Lhangjol village, Kangpokpi District and fled away from the spot. As a result of the mishap, the aforesaid rider of the motor bike and the pillion rider badly injured on their persons and also the motor bike got damaged on the frontal part. The two injured persons were reportedly evacuated at District Hospital, Kangpokpi and later, the pillion rider was referred to Oking Hospital, Kohima for further treatment. This refers to Vide G.D entry No. 40/KPI-PS/2023 dtd. 23/12/2023 at 10:00 p.m.

Hence, a Suo-Muto case is being registered under FIR No. 130(12)2023 KPI-PS u/s 279/427/338 IPC for investigation.
