Today, the 21st. February, 2022 at about 7:30 PM a mob of men and women numbering about 200 started agitation by shouting at this Police Station Gate for reason not known to us and tried to trespass into the premises of this P.S. by breaking the P.S. gate using log. In the meantime a police team led by the undersigned tried to talk to them but the angry mob paid no heed and they tried to burn the P.S. gate and they pelted stone towards our police party which hit me on the face resulting serious injuries on my person and some police personnel sustained serious injuries on their persons. The police party fired some rounds of Teargas smoke, Capsi Grenade, INSAS Rifles, AK-47, SLR, MP-5 and 9MM ammunition in the air to disperse the mob. In the incident one INSAS Rifle Bearing Regn.No.171800745 EC and one Excalibur (Foldable) Rifle Bearing Regn.No. 18483680, the P.S. sign board , water tank and some racks also got badly damaged.

Hence a suo-motu case under FIR No.13(2)2022 KPI-PS U/S 147/148/149/447/453/325/427 IPC has been registered for investigation.
