With due regards, I have the honour to report the following brief for your kind notice and necessary action.

That, today i.e. 16/2/2023 at around 11:30 am a reliable report was received from source about cultivation of Poppy plants in and around the forest area of Thungat Village and the surrounding forest areas. Acting on the information, a combined team of Kangpokpi District police led by OC/4.SPM-PS, SI Helguithang Doungel I/c MTB- Outpost, ASI Angam Himol of 4.SPM-PS and Self (ASI Ph. Doukhantian) under the overall supervision of SP-NDE rushed to the said area. 5 (five) individuals were apprehended from different locations in the said area. The individuals were later identified as:

i) Chungthang Khongrai (23) s/o Singam Khongrai of P. Moulding, P.O. Nantipha-

Wak, P.O. Lemakhang, Kangpokpi District, Manipur.

2) Seigun Harkip (41) s/o (L) Samkhulan Harkip of Ankhumbung Village, P.O. & P.C. Sakul, Kangpokpi District, Manipur.

3) Paithang Doungel (45) s/o Thangthun Doungel of Lunggang Village, P.O. & P.C. Sakul, Kangpokpi District, Manipur.

4) Lengpao Kilong (39) s/o Paithan Kilong of N. Chalang Village, P.O. & P.C. Sakul, Kangpokpi District, Manipur.
