Sub: Report.

Sir,

I have the honour to state that today i.e on 1/05/2023 at about 8:00 am a team of KPI-PS led by SI S. Raju Singh while conducting intensive regular frisking and checking of vehicles at Check Post of Kangpokpi Police Station's Gate on NH-2 under the overall instruction of Shri Th. Vikramjit Singh, MPS, SP/KPI and under the direct supervision of OC/KPI, at about 9:15 am one unregistered white colour Mahindra Scorpio (later known as RJ 48UB-0025 as per registration plate found inside the vehicle) coming towards Kangpokpi side followed by one registered Mahindra SUV 500 bearing number MN03P-8104 were stopped together for checking. While checking Mahindra SUV 500 at the rear portion, found three different size of loaded Nylon bags (white colour) keeping openly in the rear deck and on being asked, the driver who was identified as Len David Suantak (20) years S/o Khuplal Suantak of Joljam, Churachandpur District disclosed that the three nylon bags contain contraband drugs (Heroin No. 4). He further disclosed that the owner of the recovered drugs is the driver of unregistered Scorpio which was also stopped ahead of him by the police and he was identified as Lunminsang Haokip (24) yrs S/o Seikholun Haokip of Khaopijang village, Churachandpur District who was coming together with one individual namely Mangkholun Haokip (27) yrs S/o Tongjapao Haokip of Toitung village, Chandel District in the said vehicle (Scorpio). On brief examination of the three individuals, it has been ascertained that they were transporting the recovered contraband drugs together from Churachandpur for handing over at Senapati.

On confirming the presence of drugs inside the said bags, no further checking was done in order to observe formalities at the spot and the above three individuals were detained at the spot. So, immediately Senior Officer of the district namely Shri Tholu Rocky, MPS Addl. SP (L&O), Kangpokpi and 1 (one) Executive Magistrate namely Sithonliu Pamai, SDC/BO, Kangpokpi were informed about the matter and requested to be present at the spot.

Meanwhile, on tactful examination of the three detainees, they disclosed that the recovered contraband drugs (suspected to be Heroin No. 4) were supposed to be handover at Senapati to one RK. Poukhurou (50) yrs D/o Late RT Khu of Khamson Karong, PS-Senapati, District-Senapati who is waiting for the arrival at the moment. Without wasting time, teams of KPI-PS led by Addl. SP (LO/KPI) assisted by OC/KPI-PS along with Women police rushed towards Senapati in order to effectively cause arrest of RK Poukhurou by taking along the two detainees (driver and occupant of Scorpio). At the instance of the two detainees, whereabouts of RK Poukhurou was managed to locate at the approach road of TNK village and she was pick up and taken to KPI-PS for further verification in connection with the recovery of huge quantity of drugs (suspected to be Heroin No. 4).

On arrival of all police teams along with the two detainees at KPI-PS, the Executive Magistrate SDC/BO Kangpokpi was not yet arrived at the PO and waited for her arrival who was coming all the way from Imphal as the day was general holiday (May Day). On arrival of Executive magistrate at the spot, necessary formalities were started to perform. With the direction of Executive Magistrate, the detained driver of Mahindra SUV 500 (Len David Sauntak) took out the three Nylon bags (white colour) containing suspected to be contraband drugs (Heroin No.4) which were kept openly in the rear deck. On production by the detained driver (Len David), the three bags were marked as A, B & C for identification. On weighing, A weighs 8.360 kgs, B weighs 4.190 kgs and C weighs 2.750 kgs including the weight of the nylon bags. The three nylon bags marked as A, B & C were opened and found 190 (marked as 1-190) nos. of soap cases containing suspected to be Heroin (No.4) from bag A, 102 (marked as 191-292) nos. of soap cases containing suspected to be Heroin (No.4) from bag B and 59 (marked as 293-351) nos. of soap cases

containing suspected Heroin (No.4) from C. The total number of soap cases recovered from A, B & C is 351. The total recovered 351 soap cases were put into 7 (seven) transparent polythene bags and marked as Lot-1 which contains 50 soap cases (1-50), Lot-2 which contains 50 soap cases (51-100), Lot-3 which contains 50 soap cases (101-150), Lot-4 which contains 50 soap cases (151-200), Lot-5 which contains 50 soap cases (201-250), Lot-6 which contains 50 soap cases (251-300)and Lot-7 which contains 51 soap cases (301-351). On weighing the Lots, found Lot-1=2.060 kgs, Lot-2=2.170 kgs, Lot-3=2.130 kgs, Lot-4=2.140 kgs, Lot-5=2.210 kgs, Lot-6=2.080 kgs and Lot-7=2.320 kgs. The total weight of Lot-1 to Lot-7 is 15.011 kgs including the weight of transparent polythene and plastic soap cases.

On completion of necessary formalities, the total recovered 351 soap cases (Lot-1 to Lot-7) were seized in the presence of the executive magistrate and public witnesses by obtaining their respective signatures on the seizure memo prepared by me at 4:30 pm on the same day. The three detained persons who were transporting the contraband drugs (i.e suspected to be Heroin No. 4) were arrested at 4: 35 pm in the presence of witnesses by preparing a formal arrest-memo. Moreover, Miss RK Poukhurou was verified and found involved in connection with the recovery of huge quantity of drugs and she was arrested at 4:40

Following the order passed by the Hon'ble Spl. Judge, ND&PS, Manipur vide No. SPL-C/ND&PS/2019/659-663 dated 26-11-2019 corresponding Cril. Appeal No. 652 of 2012 (MANU/SC/0073/2016: (2016) 3 SC & 379) the necessary proceedings laid under ND&PS Act will be observed before the Hon'ble Court of JMFC, Kangpokpi.

Therefore, the arrested four accused persons and seized items are handed over to you for taking further necessary legal action please.
