Subject: Submission of recovered weapons and ammunitions

Sir,
I am writing to report the recovery and subsequent submission of a cache of weapons and ammunitions as part of an operation conducted by a joint team of 16 Assam Rifles and District Police Kangpokpi, in accordance with the specific input received on 12th March, 2024.

On the aforementioned date, specific input was shared by intelligent agency regarding the presence of a cache of small arms and ammunitions in the general area of Songpekjang approximately 13 Kms South West of Senapati in Kangpokpi District, Manipur. In response to this information, a column consisting of one Officer, one Junior Commissioned Officer (JCO) and sixteen other ranks (OR) from 16 Assam Rifles launched a search operation at 0900 hrs in general area Songpekjang. At around 1030 hours a suspicious patch covered with foliage was found. The joint team removed the foliage using a long stick and found a cache of weapon.

After conducting a meticulous search for over four hours, the following small arms and ammunitions and explosive were successfully recovered at 1300 hrs.

- (h) 01 x Carbine Machine Gun
- (i) 01 x Carbine Machine Gun Magazine (Regd. No. erased)
- (j) 01 x Chinese Hand Grenade
- (k) 01 x US made .32 Pistol
- (l) 01 x US made .32 Pistol Magazine
- (m) 01 x 1 inch Mor Red Round
- (n) 01 x Local made Pumpi

I would like to confirm that the recovered weapons and ammunitions will be handed over to your custody. In adherence to the legal and procedural requirements, we will be submitting these items to you for further investigation and necessary action.
