Subject: Submission of recovered item, seized items and likely contraband item brown sugar.

Sir,

I am writing to report the recovery and subsequent submission of recovered weapon, seized items and likely contraband items in accordance with ND & PS Act on 16 April 2024.

On the aforementioned date, a routine Mobile Vehicle Check Post was established at Lairouching along NH-02 wef 1800 hrs by a strength of 01 Officer, 01 JCO and 20 other ranks. At around 1825 hours three suspicious vehicles were seen moving from Senapati to Mao direction driven by one driver each. On stopping the vehicles, one of the driver fired three rounds using a pistol in the air. One jawan from the MVCP overpowered the driver and the MVCP team apprehended the three individuals at 1830 hrs. On enquiring details of the individuals, they identified themselves as following:-

- (a) Kapani Pfokreho (29yrs) S/o Pfokreho Chape of Chakumai Village, P.O. Tadubi and P.S. Mao, Sub Division Mao-Maram, Senapati District, Manipur
- (b) Daile Chamekho (29yrs) S/o Daile Eso of Chakumai Village, P.O. Tadubi and P.S. Mao, Sub Division Tadubi, Senapati District, Manipur
- (c) Losii Mangaili (33yrs) S/o Hripin Losii of Shajouba Village, P.O. Tadubi and P.S. Mao, Sub Division Tadubi, Senapati District, Manipur

Details of the Vehicles along with the details of the driver are as follows:

- (d) Hyundai Verna Regn No NLO7C7008 with Chasis No MALCU41DLDM116501*C and Engine No G4FCDU644752 driven by Kapani Pfokreho.
- (e) Maruti Suzuki Swift White Colour bearing temporary Regn No AS052566 with Chasis No MA3EHK1500245647 and Engine No K12MN1168885 driven by Daile Chamekho.
- (f) Omni Van Silver Colour with Regn No NLO7H2044 with Chasis No MAEVB11S01645322*MF and Engine No N4850415 driven by Losii Mangaili.

- (e) 1(one) packet weighing 12gm including the weight of the plastic material marked as E suspected to be contraband Brown Sugar.


- (f) 1(one) packet weighing 12gm including the weight of the plastic material marked as F suspected to be contraband Brown Sugar.

This unit approached Senapati police station to handover the individuals and seized items but expressed their unwillingness to takeover citing concerns in view of the upcoming election. The apprehended individuals along with the seized are therefore brought to your police station for further necessary legal action.
