

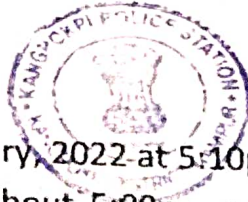

Today, the 23rd February, 2022 at 5:10pm received a reliable information that on the same day at about 5:00pm one Figo car B/Regn.No. AS01 -AQ 0881 driven by unknown coming from Kangpokpi side and proceeding towards Imphal was dashed by one Gypsy B/Regn.No. MN01 S-5117 driven by unknown coming the same direction near the Kalapahar Bazar on Nh-02 due to rash and negligent driving on the part of the driver of the above Gypsy . As a result, 2(two) occupants of the Gypsy and one unknown pedestrian received serious injuries on their persons and were evacuated to the hospital for medical treatment and both the vehicles also got badly damaged .

Hence, a suo-motu case under FIR No. 14(2)2022 KPI-PS U/S 279/338/427 IPC has been registered for investigation.
