Now my family and I are taking a shelter in Relief Camp at trade and expo centre (Lamboikhongnangkhong). My fiancé and I own a shop named "CHAOBA STORE". And I would like to report you that on the 3<sup>rd</sup> of May, 2023 at around 6pm-8pm all of my properties including my house, 2 Godowns and shop were vandalized and looted by the Kuki mob and were destructed and looted house property of amount around 55 Lakhs including my shop license which I could not remember the license number.

There is a delay in filing the application as my family and I were fled for survival; I could not report you in the earliest. In this regard, I humbly request you to undergo the investigation and take up necessary legal action against the Kuki mobs.

And for this act of kindness, I shall ever grateful to you.
