Subject: Submission of recovered weapons and ammunitions.

Sir,

I am writing to report the recovery and subsequent submission of a cache of weapons and ammunitions as part of an operation conducted by a joint team of 22 Assam Rifles and District Police Kangpokpi, in accordance with the specific input received on 23 March, 2024.

On the aforementioned date, based on specific input was shared by intelligent agency regarding the movement of unknown armed miscreants in the general area of Kotlen Hill Ranges approximately 5 Kms North of Kotlen Village in Kangpokpi District, Manipur. In response to this information, a joint team comprising 22 Assam Rifles F-Coy, Gelnal Banglabung Post and Kangpokpi Police launched a search operation today i.e. 23/03/2024 from 0815 hrs to 1100 hrs in general area of Kotlen Hill ranges. During the search operation, the unknown armed miscreants were not found in the area and suspected to be fled away and hideout. On search of the area, the following arms and ammunitions were recovered and seized from the spot at 1100 hours.

Particulars of the recovered items:

- (a) 01 x local made .22 rifle
- (b) 01 x M-16 rifle along with one magazine (Regn. No. erased)
 - (c) 08 x Cartridge live rounds.
 - (d) 12 x Bore Cartridge empty case
 - (e) 04 x 5.56 mm live rounds

The recovered arms and ammunition are being handed over to you for further necessary action.
