Sub: - Report

Sir,

I have the honour to state that today i.e the 30<sup>th</sup> March, 2022 at about 6:20 pm while a team of Kangpokpi Police Station, Kangpokpi district conducted random frisking and checking of vehicles at some vulnerable areas along Imphal-Kangpokpi road along NH-2, one passengerless Diesel Auto Rickshaw B/R-egn.No.MN08E 0177 coming from Imphal and proceeding towards Kangpokpi was stopped and detained for checking near Kalapahar Bazaar. While checking thoroughly inside the said Auto Rickshaw we came across one school bag, blue in colour (Dynamic) under the rear seat. On further checking the blue bag, a few soap cases suspected to be narcotic items were found inside the bag. On questioning, the driver identified himself as Thanginhao Khongsai, aged about 29 yrs S/o Lholkholal Khongsai of Gelnel village, A/P Kangpokpi Ward No. 17, Ahsijolneng veng, PO/PS-Kangpokpi Dist, Manipur, who admitted carrying the suspected drugs which was handover by one Phalneihoi from Pangmoul Bazar, Kangpokpi District to drop at her rental house at Kangpokpi Bus Parking area.

Thereafter, I have requested the nearby civilians to be a witness in the seizure of the suspected drugs and the conveyance however, they were reluctant to depose as witness. Meanwhile, due to vulnerability of the area and darkness, necessary formalities could not be done at the spot. With no other option, I have brought the said driver along with the vehicle and the recovered items to this PS in presence of my own police personnel and detained driver as witnesses.

On arrival at KPI-PS, I have informed our Addl. SP (Ops) Md. Abdul Kalam, gazetted officer about the matter. Accordingly, in presence of gazetted officer, the detained driver and police witnesses, the school bag was opened at Kangpokpi Police Station office and found 11 (eleven) soap cases of two blue and nine green colours containing suspected to be Heroin(No.4). On weighing the 11(eleven) soap cases by using weighing scale, it weighed 433 grams including the weight of soap cases and binding rubber.

In the light of the above facts and circumstances, seized the suspected drugs along with the involved vehicle in presence of witnesses at 7:40 pm and the detained driver was also arrested formally at 8:00 pm.

Particulars of seized items: -

1. One school bag (Blue colour) of 11 Soap cases each containing suspected to be Heroin(No.4). packed in transparent polythene packets.
2. Diesel Auto Rickshaw bearing registration no. MN08E 0177
3. One Vivo V20 mobile phone along with Airtel sim card no.9863380919
4. Driving License having no. MN-0320170004857

Following the order passed by the Hon'ble Spl. Judge (ND&PS) Manipur Vide No. SPL.-C/ND&PS/2019/659-663 dated 26-11-2019 corresponding Cril. Appeal No. 652 of 2012, (MANU/SC/0073/2016: (2016)3 SC & 379), the necessary proceedings laid under ND&PS Act will be observed before the Hon'ble Court of JMFC/Kangpokpi.

Therefore, the arrested accused person and seized items are handed over to you for taking necessary action please.
