Today ie On 01/03/2023 at around 11:30 am a joint team of Kangpokpi District Police 6th IRB, RLS (MPIC) NAB, NCB, Forest Department and SDM (Executive Magistrate) Lhungtin Block, Kangpokpi District numbering about 146 (One hundred and forty - Six) persons led by Shri Th. Thole Rocky MPS, ASP (LOI) KPI and Insp. B. Luthiang Vaiphei, OC/SKL-PS under the supervision of Shri Th. Vikramjit Singh, MPS SPIKPI carried out a mass destruction of illicit poppy plants cultivation at the Iril river bank of Leisan Village and Zhungphai Village under Lhungtin Sub-Division, Kangpokpi District, Kangpokpi District, Manipur about 21 Kms North from Saikul Police Station in which illegal poppy plantation of land covering about 20 (Twenty) acres were totally destroyed.

Hence a regular case Under FIR NO 17(03) 2023 SKL-PS U/S 18(6) NDPS Act has been registered On Suo-motto for investigation
