Sub: Report.

Sir,

I have the honour to state that today i.e on 9/5/2022 at about 1:30 pm teams of KPI-PS led by SI Hemjamang Khongsai (self) and SI S. Raju Singh while conducting intensive frisking and checking near Daili Village along NH-2 under the overall instruction of Amrita Sinha, IPS, SP/KPI, ASP(Ops) Kangpokpi and DSP(GSPM) and under the direct supervision of OC/KPI based on the information of suspicious movement of drug peddlers on NH-2, one unregistered Honda City car was stopped and during checking by the Police team, two occupants inside the car were found behaving in a very suspicious manner. The two occupants were interrogated separately at the spot and on preliminary interrogation, they admitted themselves as drug peddlers transporting illegal drugs along the highway and also admitted that they were in possession of suspected heroin No. 4 in their vehicle. The driver of the vehicle was identified as one Sonlensei Haokip (23) yrs S/o Thanglun Haokip of G.Khonom Village, Sangaikot, Churachandpur District, Manipur and the other occupant was identified as Jamgoulen Haokip (21) yrs S/o Letthang Haokip of KingKin village, Churachandpur District, Manipur. On further interrogation of Shri Sonlensei Haokip (23) yrs S/o Thanglun Haokip of G.Khonom Village, he divulged that he obtained the suspected Heroin No. 4 from one Lunminthang Haokip @Mimin Taqchapa of Molnom Village, Churachanpur # 0872990185, 09862926558.The vehicle was registered in the name of one Md. Riyajuddin Khan S/o Md. Akedali of Kwakta Ward No. 1, Kwakta, Bishnupur, MN-795133

On confirming the presence of drugs in the vehicle no further checking was done in order to observe formalities at the spot. So, immediately Senior Officers of the district namely Shri Md. Abul Kalam, MPS, ASP(Ops), Shri L. Sheimang Khongsai, MPS, DSP(GSPM) and Inspt. Kh. Sunilkumar, OC/KPI were informed. 1 (one) Executive Magistrate was also requisitioned to be present in conducting checking of the vehicle and accordingly Shri Puyam Rahulder Singh, SDC(HQ) of DC Office was deputed by DC Office, Kangpokpi. The Vehicle was searched in the presence of the above aforesaid senior Officers of the district along with independent witnesses and in the presence of the Executive Magistrate. On thorough checking of the vehicle, a modified iron box at the rear of the back seat was detected and on opening it, a good numbers of plastic soap cases suspected to be containing seat was found neatly stacked in rows in the enclosure. The plastic soap cases were removed heroin No. 4 was found neatly stacked in rows in the enclosure. The plastic soap cases were removed one by one and on counting 212 total numbers of Soap cases containing suspected Heroin No.4 were recovered from the vehicle. However, owing to the incessant rain at the spot, the entire team along with the Executive Magistrate shifted to Kangpokpi P/S for observing further formalities.

On arrival at the KPI-PS, the recovered 212 numbers of soap cases of suspected Heroin No.4weremarked as 1,2,3,4.....up to 212 and weighing of each transparent polythene packets from the marked 1,2,3,4.....up to 212 was done and recorded in presence of deputed executive magistrate along with independent witnesses and apprehended persons. The sum of the total weight of 212 transparent polythene packets containing suspected Heroin No. 4 is 2131 grams or 2.131 kgs approx. and the approximate value is estimated of Rs 63,60,000/- (Sixty-three lakhs sixty thousand) only in the local market and 31,80,00,000/- (Thirtyone crores and eighty lakhs) only in the International market.

The recovered 212 soap cases containing suspected Heroin No. 4 and other articles were seized in presence of executive magistrate, independent witnesses and apprehended persons by preparing a formal seizure memo and also obtained their signatures at 4:00 pm. The two apprehended persons were also arrested at 4:10 pm in presence of independent witnesses by preparing a formal arrest-memo.

- 1. 212 numbers of Soap cases containing suspected to be Heroin No. 4 weighing 2.131 Kgs approx. including the weight of the transparent polythene.
- 2. Two mobile phones handsets-(i) iQOO-Z3 with Airtel simcard no. 9362095874 and (ii) Realme 9 pro with Airtel simcard bearing no. 6909616010.
- 3. Two adhaar cards bearing number (i) 8772 8544 8666 and (ii) 2229 6667 4408.
- 4. Three ATM Cards of one SBI (visa)-4591500097669903 and two ICICI Bank Debit Cards-Visa bearing no. 4722542463004929 & One Master card bearing no. 5293752463001017.
- 5. One Honda City car without registration number, maroon in colour.
- 6. A Xerox copy of R.C book of Honda City B/R.No. MN O3P-4171 with registered owner named Md. Riyajuddin Khan of Kwakta Ward No. 1, Bishnupur District.

Following the order passed by the Hon'ble Spl. Judge, ND&PS, Manipur vide No. SPL-C/ND&PS/2019/659-663 dated 26-11-2019 corresponding Cril. Appeal No. 652 of 2012 (MANU/SC/0073/2016: (2016) 3 SC & 379) the necessary proceedings laid under ND&PS Act will be observed before the Hon'ble Court of JMFC, Kangpokpi.

Therefore, the arrested two accused persons and seized items are handed over to you for taking further necessary legal action please.

This is treated as an OE of case FIR No. 17(5)2022 U/s 21(C)/29/60(3) ND&PS Act
