Officer-un-charge Kangpokpi Police Station Kangpokpi District, Manipur Today the 4th May, 2023 at about 6:20 pm an unruly mob with fire arms numbering about 1000 (One Thousand) tried to intrude into the campus of Kangpokpi Police Station. In the meantime, the police personnel of the Police Station tried to disperse/stop the armed miscreants by firing several rounds in the air. However, the unknown armed miscreantsoverpowered all the personnel of the PS and had taken away 9(nine) numbers of 7.62 mm SLR, 11(eleven) numbers of License Arms which were deposited to this PS by the license holders and one box containing 500 (Five hundred) rounds of 7.62 mm ammunition by breaking the PS Arm Kotes. Further, the unknown armed miscreants broke and damaged CCTV Camera with Monitors, Wind Shield of PS 2nd Gypsy, one PS Yodha vehicle bearing Regn No. MN01AA-6307 and one XUV 500 bearing Regn. No. MN01AS-4743.
