Today, the 24<sup>th</sup> May 2022 at 7:49.am received a reliable information that on the same day at about 7:40 am one Tata Xenon (YODA), without Regn.No. coming from Dimapur and proceeding toward Imphal driven by one unknown driver knocked down one pedestrian namely Sokholun Guite (50) s/o Holkhojang Guite of Kangpokpi ward no. 15 near IT Road junction, Kangpokpi along NH-2 and again dashed one Cement Mixer Machine towed by one DI Tata B/Regn.No. AS04BC 5637 which was parked at Motor Workshop on the side along NH-2 due to rash and negligent driving on the part of the driver of the above Xenon (YODA). As a result of the mishap, the above pedestrian was seriously injured on his person and immediately evacuated to District Hospital, Kangpokpi. On arrival at the hospital, where the person succumbed to his injuries and the above vehicles and Cement Mixer Machine got badly damaged.

Hence, a suo-motu case under FIR No.18 (5)2022 KPI-PS U/S 279/338/427/304-A IPC has been registered for investigation.
