Sir,

I have the honour to report that today the 4<sup>th</sup> May, 2023 at about 6:30 pm a large number of unknown armed miscreants numbering about 1000 (One Thousand) tried to intruded into the campus of Kalapahar Police Outpost. In the meantime, the personnel of the Out Post including the Civil Police tried to disperse/stop the armed miscreants overpowered the personnel of the Out Post and had taken away 3(three) numbers of 7.62 mm SLR with 31(thirty one) live rounds, 13(Thirteen) numbers of 5.56 mm INSAS with 760 (Seven hundred and sixty) live rounds, 4(four) numbers of 7.62 X 39 mm AK Rifle (Ghatak) with 270(Two hundred seventy) live rounds, 7(seven) numbers of 7.62 X 39 mm AK Rifle with 600 (Six hundred) live rounds and 1 (one) number of 9 mm Pistol with 20 (twenty) live rounds. Further, armed miscreants broke all the locks and keys of the trunk boxes belonging to the personnel of 4<sup>th</sup> IRB posted at Kalapahar Police Out Post.

It is, therefore, requested to take up necessary legal action in this regard.
