Sir,

On 15/08/2022 at 11:00 pm Mr Jangkhohas Kipgen (58) yrs S/o Tampao Kipgen of T. Goyang Village, Kangpokpi District reported that one villager namely, Tangkhomang Khongsai (40) yrs S/o (2) Ngamkholot Khongsai also had gone to the jungle, Sangtengenglok of T. Goyang Village for work at @ 9:00 am and has not returned till late evening. On enquiry, it was learnt that his son namely, Letsanglen Khongsai, about (15) yrs was accompanying him to work. On further enquiring his son namely Letsanglen Khongsai he disclosed that he had left behind his father's body in the jungle after butchering him with a Dao at about 12 noon. He further disclosed that he covered the dead body with dry leaves at the said place and returned home carrying the mobile phone of deceased person.

You are therefore, requested to kindly take up necessary action to nab the culprit and book him under law.
