Sir,

On 15/08/2022 at 11:00pm Mr Jangkhohao Kipgen (58) yrs S/O Jampao Kipgen of T. Goyang Village, Kangpokpi District reported that one villager namely, Jangkhomang Khongsai (40) yrs S/O (L) Ngamkholok Khongsai also had gone to the jungle, Sanglotgenglok of T. Goyang Village for work at @ 9:00am and has not returned till late evening. On enquiry, It was learnt that his son namely, Letsanglen Khongsai about (15) yrs was accompanying him to work. On further enquiring his son namely Letsanglen Khongsai he disclosed that he had left behind his father's body in the jungle after butchering him with a Dao at about 12 noon. He further disclosed that he covered the dead body with dry leaves at the said place and returned home carrying the mobile phone of deceased person.

You are therefore, requested to kindly take up necessary action to nab the culprit and book him under law.
