our life.

Sir.

I, the undersigned beg to submit the following few lines for your kind consideration and necessary action thereof in view of the facts and the circumstances stated herein under:

- That, I the Villager of Ekou and I have been living at Ekou peacefully with the neighbouring Villagers. But, very unfortunately, 3/05/2023, some Armed Kuki Militants along with some Villagers of Churchandpur District stated to attempt to murder of the Villagers of Torbung Village by shooting with life around of bullet of sophisticated weapons. Thereafter, the said armed miscreant and Kuki Militants started to set fire the houses of the Torbung area.
- That, consequent upon the said incident, some armed Kuki Militants along with 2. some villagers started to attack the Villagers of Ekou by firing life of bullets from their sophisticated weapons. Thereafter, we are compelled to escape from houses so as to save our life. However, they run after us by firing life round of bullets and luckily, we could reach neighbouring Villagers where we have been saved from such criminal acts.

That, since the said incident we have been taking shelter at N.B college Khundrakpham and we also came to know that our houses have been looted, destroyed
