As soon as I, Shri Ng. Anthony Suresh, Inspector, of SKL-PS joined the Kangpokpi District Police as of Saitkup-PS on 12/01/2022, just before the 12th Manipur Legislative Assembly Election, I verbally reported to Sp/Dep. Stationing on 12/01/2022 i.e. on the day of taking charge as OC/SKL-PS, after carrying out checking of arms and Ammunitions in the Aron Koti, it was getting late and since the exhibits (including the grenades) were not properly arranged in the Malkhang, it was not safe to check the Malkhang. Moreover, I was informed by some personnel of SKL-PS that on proper handling and taking of the Malkhang of Saitkup-PS has been done since the last 10 years. So, Shri Thangpu Kipgen, Inspector, the previous OC/Saitkup-PS, and I, Ng. Anthony Suresh, Inspector the present OC/Saitkup-PS agreed to carry out handling & taking of Malkhang on another day as soon as possible whenever Inspector Thangpu Kipgen is available.

That, as no handling & taking of the Malkhang could be done on the said date, Inspector Thangpu Kipgen locked the Malkhang and took the keys of the Malkhang with him and I counter locked the Malkhang with another lock and kept the keys with me so that the Malkhang could be opened only when both Inspector Thangpu Kipgen and I are present.

That, Inspector Thangpu Kipgen could not turn up at Saitkup-PS due to busy schedule because of the State Assembly Election 2022. So I reported the matter to Sp/Kangpokpi requesting for constituting a Committee for checking the Malkhang of Saitkup-PS. Accordingly, Sp/Kangpokpi advised me to submit it in writing. Due to the Election, the matter could not be looked into.

That, after the Election, I submitted a letter dated 12th March 2022 (a copy enclosed) to Sp/Kangpokpi requesting for constituting a Committee for checking the Malkhang of Saitkup-PS and the reason for not being able to take up the Malkhang charge of Saitkup-PS earlier (a copy enclosed).



That, the superior fundup of Police, (Kangpokpi District, issued an order vide order No B-1/13/SP-141/2009 (SP-OROR) 117 btd, 25/03/2022 (a copy enclosed) constituting a special committee comprising members namely, D Sri. Seithomang Khonghai, mps - Dsp (G.Spm), 12) Inspector Ng. Anthony Sureth, OC/Saikul-PS and 3) St. Helginthang Buzang of Saikul-PS and headed by Sri Abdul Kalam, mps. Addl. Sp Cops, Kangpokpi as chairman for checking the malikans of Saikul-PS

The Additional Superior fundup of Police Cops, Kangpokpi District, issued an order vide order No B-15/ASP Cops - 141/2022) dated 6th April 2022 for checking of malikans of Saikul-PS on 11th, 12th and 13th of April 2022 accordingly. The checking of malikans on 11th, 12th and 13th of April 2022 in presence of the previous of SK-PS (Inspector Thangpa Kygn). Checking was not carried out on 11th April 2022 as Inspector Thangpa Kygn, the previous of Saikul-PS was not available on the day.

That, as the checking of malikans could not be completed on 13th April 2022, the Addl. Cops of Police Cops, Kangpokpi issued another order vide order No B-15/ASP Cops - 141/2022 (OROR) btd 14th April 2022 (a copy enclosed) for continuing the checking of malikans on 18th, 19th and 20th of April 2022.

That, checking of the malikans of Saikul-PS are conducted on 18th April 2022 in presence of the previous of SK-PS, during the checking, some exhibits were found missing or suspected to be manipulated, and exhibit numbers of cases (contraband Gangs) for 17 (Seventeen) could not be identified as the exhibits were in a dilapidated condition and there were signs of Gangs eaten by rats etc. Instead of about 24965 kg of Gangs were found in the malikans Godown. Detailed statements of missing exhibits are enclosed as annexure 11 and annexure 12.

So, a regular case under F.R.A. 19(8) 2022, SK-PS of 210/409, 120-B & 29 Police Act 1861, has been registered on basis of the Special Committee to the higher authority and waited for further orders.
