Sir,

Based on intelligence input received from own sources, it was revealed that one suspected UG cadre namely Helminthang Haokip ((37) s/o Seijahao Haokip of Khomunnom Village, I.T Road, A/P T. Tuinom village, Kangpokpi District, Manipur was present at general areas of T. Tuinom village, Kangpokpi District, Manipur who was suspected UG Cadre to have been engaged in extortion and tax collection along NH-2. Based on this input a team of 22nd Assam Rifles led by Post Commander along with Police team including one Women Police officer from Kangpokpi Police Station launched a search and cordon operation at around 11:00.pm at T. Tuinom village and apprehended the above mentioned suspected cadre at 11:20 pm. at his residence at T. Tuinom village and seized the following items from his possession.

Seized Items:

1. 1 (one) Country made 9 mm Pistol.
2. 2(two) live rounds of 9 mm ammunitions.
3. 1 (one) Radio Set.
4. 3 (three) Extortion Slips.

I, therefore, request your good self to take up necessary legal action in this regard.
