Subject: Report.

Sir,

I have the honour to state that, on 28/05/2023 at around 02:00 pm Some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 100-200 persons carrying sophisticated automatic weapons like AK Rilfes, SLR, INSAS and LMG forcefully entered our village, H. Molhoi village about 10 Km south West from Saikul PS. They vandalised and looted all the moveable and vaulable properties and burnt down all the remaining including my house into ashes leaving us homeless. They also killed our cattles and livestock's and other domestic animals. In order to safe our lives we left our village and fled to a nearby safe location and as of now I along with my family temporarily stayed at Shongthu Avenue Relief Camp, Saikul, Kangpokpi District, Manipur. The list of properties destroyed or lost are mentioned in the **Annexure (enclosed)**. The Approximate value of lost properties is calculated at about Rs. 48,34,000/- (Fourty eight lakhs thirtyfour thousand) only.

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.


