

Sir,

I have the honour to report that, today, i.e. 2/11/2022 at around 2:10 pm I alongwith a team of Saikul - PS, conducted ILP Card verification of some Non-locals (Non-resident of Manipur) numbering about 6(six) persons who were engaged in house construction of Mangten Kipjen (48) yrs S/o (4) Seikhohao Kipjen at Saikul Bazar areas. while conducting the verification, one of the Non-locals namely, Pier Uddin Laskar aged about 25 yrs S/o Rahim Uddin Laskar of Madhubond, Lakhimpur Road, Silchar, Assam, was found to possess invalid/expired ILP Card (valid upto 20/10/2022). He was apprehended at the spot at about 3:30 pm.
