I have the honour to report that, today, i.e. 2/11/2022 at around 2:10 pm I alongwith a team of Saikul-PS, conducted ILP Card Verification of Some Non-locals (Non-Resident of Manipur) numbering about 6(six) persons who were engaged in house construction of Manglen Kipgen (48) yrs S/o (L) Seikhchoao Kipgen at Saikul Bazar areas.
