Today I,e. 17/1/2022 at @ 8:00 am a joint team led by MD Abul Kalam Addl.SP(OPS)KPI, SDC/EM-Kangchup Geljang, OC/KPI-PS, NAB (Narcotic and Affairs of Border), Forest Department Kangpokpi, Teams of 33th AR-Hengbung post, Personnel of Reserve Line-KPI, Personnel of G-SPM-PS and Youth Volunteers of T.Khullen village under the supervision of Smt. Amrita Sinha, IPS, SP-Kangpokpi, Manipur conducted Poppy Plants destruction drive at T-Khullen (Tumuyon khullen) hill range leading upto Heijang village hill range, Kangpokpi District, Manipur in which illegal Poppy Plantation of about 18 Acres were completely destroyed. The approximate values of the destroyed Poppy Plants is Rs.8,400,000 Lakhs (Eighty-four lakhs) only.
