

Sir,

I have the honour to report that today, the 13th January, 2023 from 8:00 A.M. to 2:30 P.M. a joint team of Kangpokpi District Police and Kangpokpi Forest led by OC/G.SPM-PS, Range Forest Officer, Kangpokpi under the supervision of SP-Kangpokpi and DFO/Kangpokpi conducted destruction of illicit Poppy plants at Phoibung Hill Range inside KK (Kanglatongbi Kangpokpi) reserved forest under the jurisdiction of Kangpokpi Police Station in which illegal Poppy plantation of approximately 30 acres which were planted by breaking of land prohibited in the reserved forest land were completely destroyed.

It is therefore, requested kindly to take up further necessary legal action as per provision of law.
