Sir,

- On 10 Jan 2023 at around 1300 hrs, info received of mov of drug peddlers near Tusam village area under Saikul PS, Kangpokpi District, Manipur. A sto of 01-00-10 move to Tusam village (CR 515183) and placed MVCP at 1445 hrs. At 1500 hrs one Alto car bearing Regd. No. MN01S 5992 (white colour) was stopped for verification and found 3 (three) occupants inside the car. On preliminary interrogation, the driver of the Alto car identified himself as Letgoumang Touthang (30) yrs S/O (L) Shokhongam Touthang of Touthang weng, Saikul, Kangpokpi District, Manipur. He further revealed that he is a drugs peddlers and transporting illegal drugs from Imphal to Tusam village.
2. The other two occupants identified themselves as (1) Thangweikup Hakiip (40) yrs S/O (L) Thanglet Hakiip of Sengphel village, Ukhrul District, Manipur and (2) Leishangthem Surchanbi Singh (38) yrs S/O (L) Leishangthem Khundombi Singh of Nongpok Kakching Mayai Leikai, Imphal East, Manipur. They were arrested at 1520 hrs.
3. The following articles were seized from their possession:
- (1) 2 (two) black bags containing suspected opium having a total weight of about 23.280 Kgs. including the weight of the plastic packets.
 - (2) Indian currency Rs. 1,90,000/- (One lakh ninety thousand).
 - (3) 1 (one) Alto car (white colour) bearing Regd. No. MN01S 5992 along with key.
4. It is, therefore, requested you to book the culprits according to law.
