

Sub : FILING OF FIR AGAINST RECOVERY OF WEAPON CACHE

Sir,

1. On 05 Jan 2024 based on the specific input a spl search ops with strength of 01/01/16 of 16 Assam Rifles along with police reps from KPI PS was launched on 5<sup>th</sup> Jan at 1950 hrs from COB Hengbung towards gen A between S Changoubung and Maohing to appre and recovery the miscreants and war like items.
2. On 6<sup>th</sup> Jan at 0745 hrs during the search and domination in gen A of S.Changoubung move of few suspected Indls with weapons were noticed by petrol party. While challenging them to stop, they started to run inside the jungle. Petrol party followed them but due to dense jungle they managed to escape.
3. During the through search of the jungle following recovery were made at 0810 hrs.
  - (a) Local made MOR- 03
  - (b) CMG with mag - 01
  - (c) .32 mm Pistol without mag - 01

No casualties/damage to property/collateral damage has been reported.

You are requested to kindly file an FIR against the above mentioned recovered arms & ammunitions.
