I, Mr. Nehminlal Haokip age about 28 years, S/o, Lunsei Haokip in a permanent inhabitant of T.Kholep Village of Teiseng District Churachandpur(Lamka) Manipur Pin Code 795128. As an active NGO staff of InSIDE North East, office located at Thangkanphai, Saikul, Kangpokpi district from 2021, for the post of Teacher. I was placed at T.Wakonphai Village Kangpokpi District 795128 Manipur, by InSIDE North East.

That, I am presently evacuated and staying at Thangkanphai, Saikul Kangpokpi District 795118 Manipur.

That, on the intervening night of the 28th May,2023 at around 2:30 PM some unknown miscreants suspected to be the member of Manipur Youth Organization, Meitei Leepun, Kangleipak Kanba Lup and Arambai Tengol of 100 to 200 armed persons have burnt the Teacher quarter building where I stayed at T. Wakonphai.

Due to lack of legal knowledge I could not report the incident in time.

They also robbed my properties which worth Rs. 1,36,609/- (one lakh thirty six thousand six hundred and nine)

The list of properties destroyed or loss are mentioned in the Annexure (enclosed).

On the fact and circumstances above you are requested to book the culprits as per law of the country.

This report is treated as an O.E. of FIR No. 2 (01) 2024 SKL-Pe US 153 A/147/397/398/427/436/447/448/34 IR & 25 (1-C) A. Act & See 3(ii)(3) of SC/ST (Prevention of Afrocifics) Act.
