

Sub :- Filing of FIR against Armed Rioters

Sir,

1. Internal Security Duty columns of Assam Rifles were deployed in the general area of Kanglatongbi for protection of civilians and maintaining peace in terms of the requisition by the Govt of Manipur. On 16 July 23 the said Assam Rifles columns deployed at Phaileng carried out joint combing operation with CRPF and Police rep from KPI PS in Gen A Phaileng ridge line. At 1035 hrs on 16 July 23, suspicious movement was observed by the column in area South East of Phaileng. On being challenged, column was fired upon by unknown armed miscreants. On being fired upon by the armed miscreants and under threat to own life and that of civilians in the area, Assam Rifles troops responded in a calibrated manner with controlled fire, in self defense and for protection of civilian in the area. Firing stopped at 1050 hrs. No casualties were reported by the locals/state forces during the said incidents.

2. Thereafter, thorough search of the area was carried out by joint column. During the search five bunkers were destroyed and following recovery were made:-

You are requested to kindly file an FIR against unknown armed rioters and investigate the incident for attempt to murder with deadly weapons, to deter public servants suppressing riots, causing hurt with dangerous weapons and unlawful carriage of dangerous weapons and unauthorised usage of fire arms and ammunition to include automatic weapons.
