

I, the undersigned have the honour to state that a large number of unidentified people belonging to the Kuki community with deadly weapons and sophisticated arms including Kuki militant groups stormed the Meitei inhabited areas of Saikul Bazar under Saikul P.S., Kangpokpi District on 30/5/2023 at @ 5:30 pm. The said unidentified groups vandalized my rented house of Palen Touthang (50) yrs. of Saikul Bazar and they looted my house hold materials, clinic and pharmacy items. In such terrible acts of the said unidentified groups, I along with my family members run away my home to save our life. In that unfortunate incident I have lost my household materials along with clinic and pharmacy items property amounting to a total amount of Rs:- 16,00,000/- (Sixteen Lakh) only.

It is therefore, requested kindly initiate and take necessary legal actions against the accused persons involved in the said inhuman and barbarous act, as per law of the land as early as possible. I couldn't able to submit my complain report in time due to prevailing inconvenient situation.
