

Sir,

I have the honour to report that I have been settling at Thangkanphai village, P.O. & P.S. Saikhul Sub-Divison, Kangpokpi Dist., Manipur since 1985 as my father bought a plot which was purchased from the Village Chief in the year 1985 and constructed my own house (Katcha house). I along with my daughter, my son-in-law and two children were dwelling in our house.

On 03/05/2023 at about 4.30pm while I along with my whole family were in our house, some unknown persons numbering about 300 suspected to be Kuki were coming towards my house holding arms and sticks. On seeing the situation my whole family ran towards river side which was on the northern side of our house, to save our lives. On the way when we looked back our house was surrounded by Kuki people and saw damaging our house. Whole night we stayed in the jungle. And on 04/05/2023, I informed to the Saikhul Police Station on phone, after that we were transported and reached Sagolmang Bazar at 4.30 pm with the help of Saikhul Police team and Assam Rifles.

It is therefore prayed kindly to take up necessary legal action against the culprits as per the law of the land.
